What is this product?


Type: This product is a UCITS fund. **Term:** No fixed term.

Objectives: The investment objective of the Fund is to seek capital appreciation. The Fund invests primarily in Equities and equity related securities (including ADRs and MLPs) issued by companies of any size and located both inside and outside of the U.S., including those which are organised, headquartered or do a substantial amount of their business in Emerging Market Countries. Although there is no limit on the amount of the Fund's assets that may be invested in companies located in any one country, the Fund seeks to invest in companies in a broad range of countries and typically invests in approximately 15 industries of GICS. The Fund may use FDI for hedging, investment or efficient portfolio management purposes. Using FDI may introduce leverage into the Fund. The Investment Manager utilises investment technology to analyse a range of financial data to select companies that it believes have a market value that is undervalued relative to its future prospects. Any income less expenses will be accumulated and reinvested into the net assets of the Fund.
